





Skills for Care is the strategic workforce development and planning body for adult social care in England. We work with employers, Government, and partners to ensure social care has the right people, skills, and support required to deliver the highest quality care and support, now and in the future. The information within this summary has been produced by Skills for Care using the Adult Social Care Workforce Data Set (ASC-WDS). We use the data collected by the ASC-WDS to create workforce models that, in turn, allow for estimates of the whole adult social care workforce and its characteristics to be produced. The * notation indicates the figure has been suppressed.

Size and structure of the workforce

In 2021/22 the adult social care sector in England had an estimated 17,900 organisations with 39,000



care-providing locations and a workforce of around 1.79 million posts. In Calderdale there were an estimated 6,000 posts in adult social care, split between local authorities (10%), independent sector providers (76%) and posts working for direct payment recipients (14%). As at March 2022, Calderdale contained 92 CQC-regulated services; of these, 50 were residential and 42 were non-residential services.

The total number of posts in Calderdale was around 6,000 in 2021/22. This was comprised of 5,600 filled posts and 475 vacancies. Since the previous year, the total number of posts was relatively similar, the number of filled posts has decreased by 150 (-3%) and the number of vacancies has increased by 225 (89%).

If the workforce grows proportionally to the projected number of people aged 65 and over then the total number of adult social care posts in the Yorkshire and the Humber region will increase by 25% (from 173,000 to 216,000 post) between 2021 and 2035.

From here on, the figures in this report refer to the 4,800 filled posts in the independent sector and local authority in Calderdale. Filled posts working for direct payment recipients are not included.

The information in this report was provided by local authorities as at September 2021 and by independent sector employers as at March 2022.

Recruitment and retention

Skills for Care estimates that the staff turnover rate in Calderdale was 24.1%, which was lower than the region average of 28.1% and lower than England, at 30.0%. Not all turnover results in workers leaving the sector, around two thirds (64%) of starters were recruited from within the adult social care sector, therefore although employers need to recruit to these posts, the sector retains their skills and experience.

Adult social care has an experienced 'core' of workers. Workers in Calderdale had on average 9.4 years of experience in the sector and 75% of the workforce had been working in the sector for at least three years.

Employment information

We estimate Calderdale had 4,800 adult social care filled posts in the local authority and independent sectors.

These included 450 managerial roles, 200 regulated professionals, 3,400 direct care (including 2,700 care workers), and 700 othernon-care proving roles.

The average number of sickness days taken in the last year in Calderdale was 9.6, (8.8 in Yorkshire and the Humber and 8.3 across England). With an estimated directly employed workforce of 4,500, this means employers in Calderdale lost approximately 43,000 days to sickness in 2021/22. Across England levels of staff sickness have nearly doubled compared before the COVID-19 pandemic, increasing from 4.6 days in 2019/20 to 8.1 days in 2021/22. However, data from the ASC-WDS has shown sickness has decreased since March 2022.

Less than a quarter (16%) of the workforce in Calderdale were on zero-hours contracts. Around half (49%) of the workforce usually worked full-time hours and 51% were part-time.

Workforce demographics

The majority (84%) of the workforce in Calderdale were female, and the average age was 43.8 years old. Workers aged



24 and under made up 9% of the workforce and workers aged over 55 represented 27%. Given this age profile approximately 1,300 posts will be reaching retirement age in the next 10 years.

Nationality varied by region, across England 83% of the workforce identified as British, while in the Yorkshire and the Humber region this was 93%. An estimated 96% of the workforce in Calderdale identified as British, 1% identified as of an EU nationality and 2% a non-EU nationality, therefore there was a similar reliance on EU and non-EU workers

Pay



Table 1 shows the full-time equivalent annual or hourly pay rate of selected job roles in Calderdale (area), Yorkshire and the Humber (region) and

England. All figures represent the independent sector as at March 2022, except social workers which represent the local authority sector as at September 2021. At the time of analysis, the National Living Wage was £8.91.

Qualifications, training and skills

We believe that everyone working in adult social care should be able to take part in learning and development so that they can carry out their roles effectively. Learning and development helps everyone to develop the right skills and knowledge to enable them to provide high-quality care and support.

Skills for Care estimates show that 49% of the direct care providing workforce in Calderdale hold a *relevant* adult social care qualification (51% in Yorkshire and the Humber and 46% in England).

Raw data from the ASC-WDS showed, of those workers without a relevant adult social care qualification recorded, 53% had five or more years of experience in the adult social care sector, 51% had engaged with the Care Certificate and 73% had completed training.

Factors affecting turnover

Together with a data science specialist, we used ASC-WDS information to create machine learning models that were used to assess which variables had an effect on adult social care workers' propensity to leave their posts.

Across England, variables that influence the likelihood of a worker leaving their role were:

- Workers who travelled further were more likely to leave.
- Those under 25, and over 60 years old, were more likely to leave their posts.
- Turnover decreased with higher levels of experience working in the sector.
- Likelihood of leaving decreased as pay levels increased.
- Likelihood of leaving decreased with higher levels of experience in role.
- Likelihood of leaving decreased if workers had more training.
- Turnover decreased if workers had a higher number of contracted hours.
- Likelihood of leaving decreased if workers had fewer sickness days.
- Workers on zero-hours contracts were more likely to leave their posts.
- Likelihood of high turnover rates increased if the establishment had high turnover historically.
