

# A summary of the adult social care sector and workforce in Portsmouth

2017/18

**Skills for Care, as the leading source of adult social care workforce intelligence, has created this summary because good quality information about the workforce is vital to help inform planning and decision making. This will contribute to the delivery of high quality social care services and improve outcomes for people who use these services, both now and in the future.**

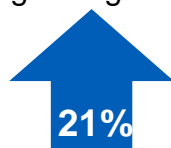
The information within this summary has been produced by Skills for Care using the National Minimum Data Set for Social Care ([NMDS-SC](#)). We use the data collected by the NMDS-SC to create workforce models that, in turn, allow for estimates of the whole adult social care workforce and its characteristics to be produced. The \* notation throughout refers to use of raw data from the NMDS-SC.

## Size and structure of the workforce in this area



In 2017 the adult social care sector in England had an estimated 21,200 organisations, 41,000 care providing locations and 1.6 million jobs. In Portsmouth there were an estimated **4,500** jobs in adult social care split between local authorities (**18%**), independent sector providers (**75%**) and jobs for direct payment recipients (**7%**). As at September 2018 Portsmouth contained 77 CQC regulated services; of these, 47 were residential and 30 were non-residential services.

The adult social care workforce is growing. Across England it has increased by 21% since 2009, and in the South East region, by 4% since 2012.



If the workforce grows proportionally to the projected number of people aged 65 and over then the number of adult social care jobs in the South East region will increase by 48% (from 255,000 to 380,000 jobs) by 2035. The adult social care sector was estimated to contribute £38.5 billion per annum to the English economy and in the South East region, this contribution was estimated to be between £6.7 and £8.1 billion<sup>1</sup>. Almost half of this is estimated to be the wage bill of the sector. ## Recruitment and retention

Skills for Care estimates that the turnover rate in Portsmouth was 33.6%, which was higher than the region average of 30.3% and similar to England at 30.70%. Not all turnover results in workers leaving the sector, over three quarters (80%) of those recruited came from within the adult social care sector, therefore although employers need to recruit to these posts, the sector retains their skills and experience.

Adult social care has an experienced 'core' of workers. Workers in Portsmouth had on average 7.9 years of experience in the sector and 65% of the workforce had been working in the sector for at least three years.

Skills for Care estimates that in Portsmouth, 6.8% of roles in adult social care were vacant, this equates to around 275 vacancies at any one time. This vacancy rate was similar to the region average, at 8.7% and similar to England at 8.0%.

### Staffing overview

The estimated number of adult social care jobs in the Portsmouth area was 4,500 including 375 managerial roles, 225 regulated professionals, 3,300 direct care (including 2,300 care workers), and 650 other-non-care proving roles.

The average number of sickness days taken in the last year in Portsmouth was 6.1 (4.8 in South East and 5.1 across England). With an estimated directly employed workforce of 3,800 this would mean employers in Portsmouth lost approximately 23,000 days to sickness in 2017/18.

Around a third (31%) of the workforce in Portsmouth were on zero-hours contracts.

**Chart 1. Proportion of workers on zero hours contracts by area**



Approximately half (52%) of the workforce worked on a full-time basis, 38% were part-time and the remaining 11% had no fixed hours.

### Demographics

The majority (84%) of the workforce in Portsmouth were female and the average age was 42.6 years old.



Those aged 24 and under made up 10% of the workforce and those aged over 55 represented 22%. Given this age profile approximately 1,000 people will be reaching retirement age in the next 10 years.

Nationality varied by region, in England 83% of the workforce were British, while in South East this was 77%. An estimated 89% of the workforce in Portsmouth had a British nationality, 5% had an EU nationality and 6% had a non-EU nationality, therefore there was a similar reliance on EU and non-EU workers.

### Pay

Table 1 shows the full-time equivalent annual or hourly pay rate of selected job roles in Portsmouth (area), South East (region) and England. These data were captured for the local authority sector as at September 2017 and the independent sector as at March 2018. At the time of analysis the National Living Wage was £7.50.

Please note that pay varies by sector, with local authority pay generally being higher than independent sector pay.

## Qualifications, training and skills

Skills for Care believes that everyone working in adult social care should be able to take part in learning and development so they can carry out their role effectively, this will help to develop the right skills and knowledge so they can provide high quality care and support.



Skills for Care estimates show that 55% of the workforce in Portsmouth hold a *relevant* adult social care qualification (49% in South East and 53% in England).

Of those workers without a relevant adult social care qualification recorded, 50% had three or more years of experience in the adult social care sector, 87% had completed or were in the process of an induction and 42% had engaged with the Care Certificate.
