#### What data do we need to enter to be eligible for WDF?

Should I apply for WDF through a partnership or directLY to Skills for Care?

If your local authority area is on the advertised list, you can apply directly to Skills for Care. Otherwise, you should apply via a partnership.

### If you are a national organisation, would you join a partnership or apply directly via Skills for Care?

There are national partnerships available for you to join if you have multiple sites across different areas.

If providers use ASC-WDS as a record of staff training, are they able to be sent/printed off to give to CQC or local authority staff as evidence of training being up-to-date? Yes, you are able to download a training report in excel. It shows a summary and a copy of the records.

# Are the essential training programmes available to home care providers? If so, how do you tailor the training to reach a workforce that is field based?

Yes, the programmes are available to all adult social care employers. The training is delivered by our endorsed training providers, who deliver in different methods, including virtually. For more information, please visit: Access fully funded essential training programmes

Do home care providers need to be CQC regulated to acquire an ASC-WDS account? No, care providers do not need to be CQC registered to join ASC-WDS.

## How do I merge the data from ASC-WDS if I use a learning management system platform?

Nellsar Ltd. Use a learning management system, and to merge the two, they map the data across both systems using spreadsheets to ensure that all learning is captured in ASC-WDS, as a centralised point.
